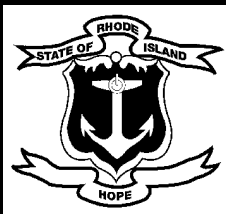
Reentry Vision Statement

An integrated statewide system that fosters the preparation & gradual transition of incarcerated individuals to productive, healthy, & crime-free lives.



The Case for Reentry

- RI ranked 8th in the nation in the rate of total correctional supervision (incarceration, probation and parole). It was the highest in the Northeast.
- Approximately 4,000 offenders are released from sentences every year
- 90% of the sentenced inmates released from the ACI remain under DOC supervision on Probation or Parole
- There are approximately 21,000 Probation & Parole offenders on the streets of RI everyday (1 of every 21 adult males)
- 34% of all sentenced inmates released from the ACI return on new sentences within one year
- Over half of all sentenced admissions to the ACI are Probation or Parole Violators
- This churning of repeat offenders through the system represents a risk to public safety and is a major contributor to the prison population and costs.

Reentry: A statewide systems approach

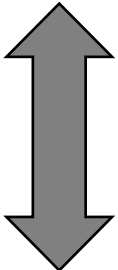
(Development of governance structure for reentry)

- Governor issues executive order 04-02 directing all agencies to participate in reentry
- With assistance from a consultant provided by NIC a tiered structure is designed to address issues of reentry
- The Governor's Steering Committee on Prisoner Reentry was established to create a comprehensive plan and systematic approach to promoting reentry strategies for all offenders.
- The Reentry Steering Committee shall:
 - a. Provide ongoing coordination at the executive level
 - b. Ensure agreement on overall policy direction;
 - c. Resolve policies and practices that impede successful reintegration;
 - d. Assign senior staff from the departments to implement established priorities.

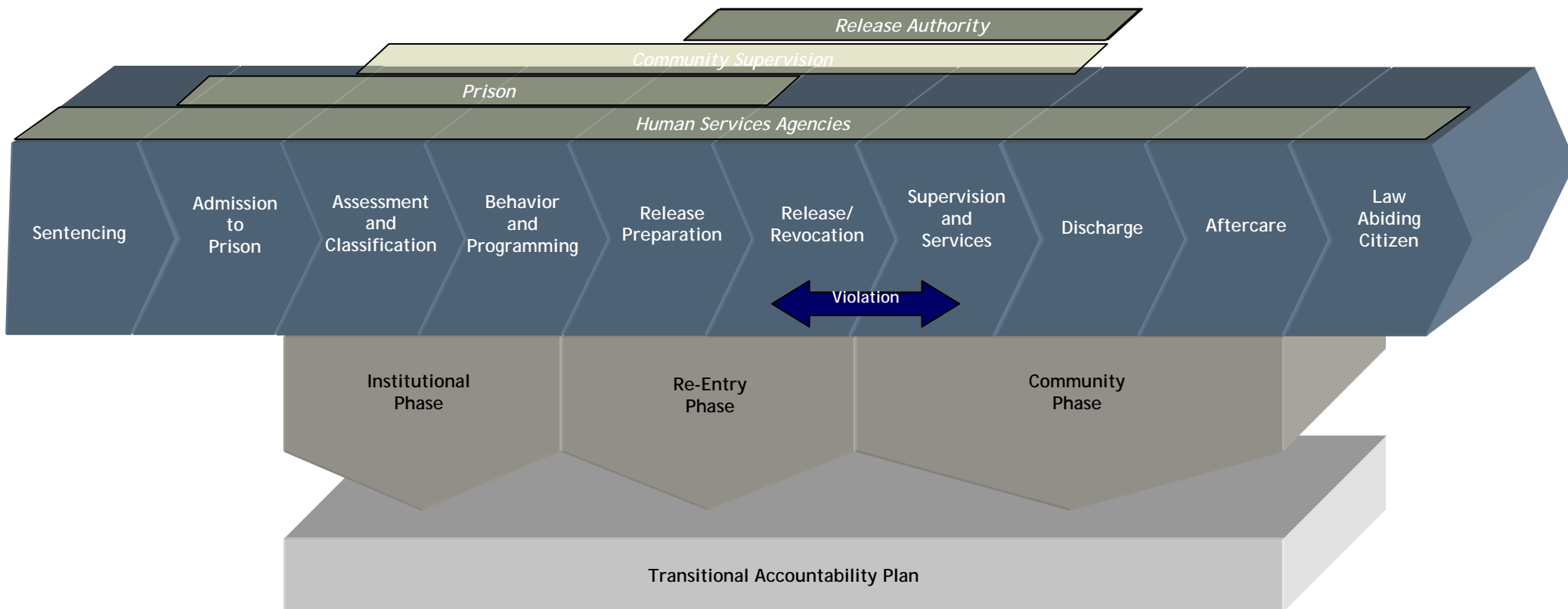

Transition from Prison to Community Model

- Best practices model focuses on 8 decision points that impact offender reentry
- Integration of operational practice with reentry goals





Level of Service Inventory – Revised (LSI-R)

- The LSI-R is a systematic way of collecting risk & needs information important to offender treatment planning (Andrews & Bonta 1995).
- LSI-R scores provide corrections personnel with a numeric estimate of each offender's risks and needs, enabling them to assign offenders to appropriate services (Petersilia 2003).
- The LSI-R can be used to help identify treatment goals & help reduce the risk of future criminal behavior (Petersilia 2003).



Level of Service Inventory – Revised (LSI-R)

Level of service needs is measured in these categories:

- Criminal history
- Financial
- Accommodation
- Companions
- Emotional / Personal
- Education / Employment
- Family / Marital
- Leisure / Recreation
- Alcohol / Drug Problem
- Attitudes / Orientation



Program/Interventions

- Education/Vocational Training
- Substance Abuse Treatment
- Institutional Programs
- Transitional Services/Discharge Planning
- Examples of Father Specific programming:
 - Parenting Education – Long Distance Dads
 - Special Saturday Parenting Visitation
 - Books Beyond
 - RI Men of Hope group



RIDOC and Fatherhood

- Strong working relationship with Child Support, RIC Child Welfare Institute
- Active member of the RI Fatherhood Coalition
- Governor's Workforce Plan now includes language supporting non-custodial fathers.

What does the LORTE model do?

- Allows one to anticipate reactions and behaviors to emotional events.
- Defines, tracks, and explains adverse behavior.
- Enables youth to better control situational outcomes.
- Simplifies the task of creating effective programs, training and “treatment” goals.
